ABOUT THE FILM

FREEDOM is the only feature-length documentary in the United States made from a faith perspective on the criminalization of prayer and so-called "conversion therapy" bans. Produced by Fish Tales Production Company Inc., the film exposes a coordinated global effort to outlaw voluntary faith-based counseling — and the real human cost of that assault on religious liberty.

With more than 20 interview subjects drawn from over 40 interviews conducted across multiple countries, FREEDOM gives voice to Christian counselors, psychologists, attorneys, pastors, and individuals who have lived this story — people whose experiences have been silenced, misrepresented, and criminalized.

A LANDMARK MOMENT

In March 2026, Matthew Grech of Malta — featured in FREEDOM — was fully acquitted following the first-ever international criminal prosecution under a conversion practices ban. His case brought global attention to the real consequences of these laws for people of faith.

THE OPPOSITION IS ALREADY IN THE CHURCH

The PBS documentary *Mama Bears* is quietly finding its way into congregations across America, presenting a one-sided narrative to the very audiences who most need to hear the truth. **FREEDOM is the counter-narrative that belongs in those same rooms.**

DUAL AUDIENCE

- ① Christians who have been misled about what counselors actually do
- ② LGBTQ individuals who have also been misled — no credentialed professionals do what activists accuse them of

WHY THIS FILM. WHY NOW.

The U.S. Supreme Court is expected to rule on *Chiles v. Salazar* — a direct challenge to state conversion therapy bans — before June 2026. A ruling in favor of counseling freedom could strike down bans in more than 20 states. A ruling against could entrench them nationwide.

FREEDOM was built for this moment. It is the only film that puts a human face on what is at stake — and it is ready for distribution now.
